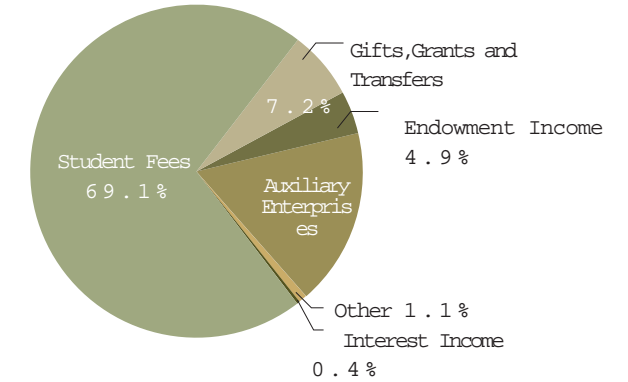

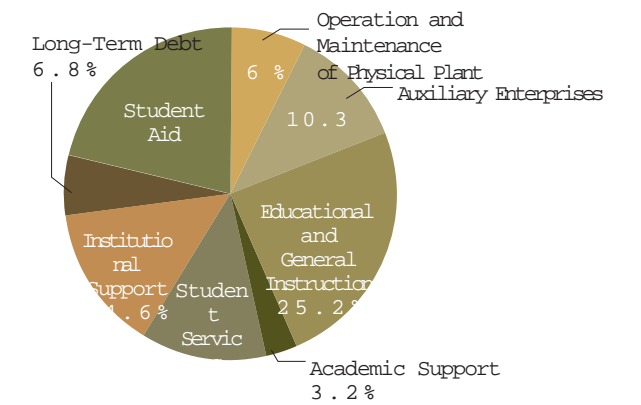

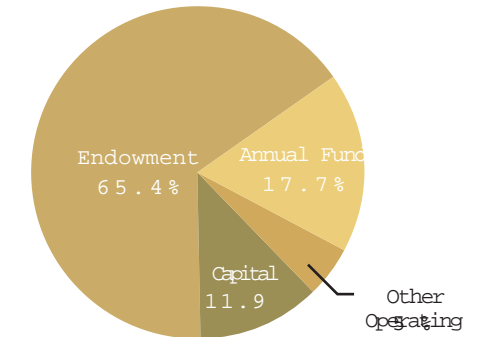

**Net Excess of Revenues Over Expenditures**     \$ 375,843

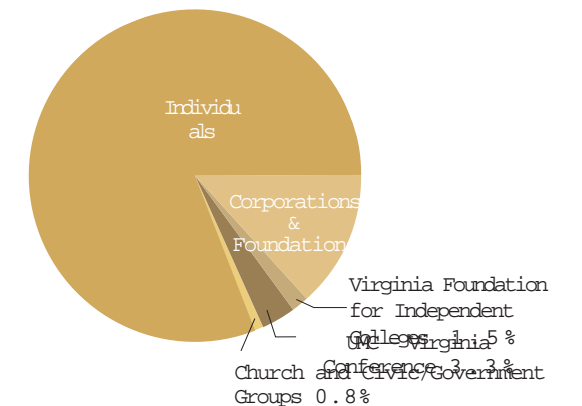
